NEW REVISED BYLAWS – TO BE VOTED ON AT THE JUNE MEETING

THE DELCO BIRD CLUB BY- LAWS, Revised June 2007

ARTICLE I - Name

Sec. 1 The Club shall be known as the Delco Bird Club. This will be a non-profit organization.

Sec. 2 The Club known as Delco Bird Club was founded the month of January of the year Nineteen hundred and Ninety Seven.

Sec. 3 The founder and co-founder of the Club known as Delco Bird Club are Christine Phelps and Sue Grosso.

ARTICLE 11. - Objectives

Sec. 1 The purpose of the Club will be to create and maintain lasting friendship among owners and breeders of caged birds.

Sec.2 To help members with problems concerning their birds.

Sec.3 To encourage the interest and educate the general public about birds as charming and loving pets.

Sec.4 To become more informed of the dietary requirements and promote' better nutrition in pet birds.

Sec.5. To encourage and assist anyone in their aviculture interest through the exchange of knowledge.

Sec. 6. To keep members informed through the monthly newsletter.

Sec. 7 To keep abreast of and participate in state and national legislation and health issues pertaining to the keeping of birds.

ARTICLE III - Meetings

Sec. 1 Meetings will be regularly held on the second (2nd) Thursday of each month and called to order promptly at 7:00 PM. If the business meeting extends longer than 1/2 hour, business will be tabled until after the program.

Sec. 2 There must be a minimum of 5 meetings held by the Board of Directors per year.

ARTICLE IV - Officers and Board of Directors

Sec. 1 The officers of the Club shall be a President, a 1st Vice President, a 2nd Vice President, a Secretary and a Treasurer all voted on by the membership for **a (2) year term. The voting will take place every odd year.**

Sec. 2 The Club shall have a Board of Directors consisting of the President, 1st Vice President, 2nd Vice President, Secretary, Treasurer, and **up to but no more than 5 Membership Representatives will be appointed by the Board of Directors on a "as needed" basis. The appointment of the Membership Representatives shall take place after the election of the Board of Directors.**

Sec. 3 Only one (1) member per household may serve on the Board of Directors at a time.

Sec. 4 The Delco Bird Club shall have a Director of Outreach Programs, who shall coordinate all Outreach activities. Such Director will be appointed by the Board of Directors and shall carry one (1) vote.

Sec. 5 No one shall be eligible to run for a Board position if they so hold another Board position with another club, but can be so appointed by the Board of Director's if needed.

ARTICLE V - Duties of Officers and Board of Directors

Sec. 1 The President shall call the meeting to order and serve as coordinator of all activities.

Sec. 2 The President shall act as Club representative or appoint a member.

Sec. 3 The 1st Vice President shall assist the President, as needed and shall preside at the meetings in the absence of the President. The 1st Vice President shall assume the office and duties of the President in the event the latter can no longer continue in his/her office. The 1st Vice President is also the- Program Director.

Sec. 4 The 2nd Vice President shall also assist the President and 1st Vice President as needed. The 2nd Vice President shall be second in line to succeed the president, and first in line to succeed the 1st Vice President. He/she shall be responsible for serving as fund raising coordinator.

Sec; 5 The Secretary shall attend all general and Board meetings or arrange for a suitable replacement and keep a full and correct record of the proceedings and submit this record to the Newsletter Editor for Inclusion in the monthly newsletter. He/She shall also handle all Club correspondence.

Sec.6 The Treasurer shall receive and have charge of all monies belonging to the-Club and shall disperse it at the direction of the Board of Directors. He/she is also responsible for collection of all membership fees and forwarding membership forms to the Member Representative who will keep an accurate record of membership status. On the expiration of his/her term of office, he/she will turn all monies and accounts (including records) over to the incoming Treasurer.

Sec. 7 The Membership Representative shall be responsible for presenting the opinions, views, and grievances to the Board for the general membership. Shall also assist any officers in fulfillment of the club duties as required.

Sec. 8 The Board of Directors shall exercise, conduct, and account for the property and affairs of the Club. In order to be an officer on the Board, said officer must be a member in good standing. A member shall be considered a

member in good standing if their yearly dues are paid up-to-date' and they have' attended 50% of the meetings in the previous year. A member of the Board of Directors missing 3 or more consecutive Board meetings will be reviewed for dismissal from the position and said position will be open to appointment by the Board for the completion of term if needed.

ARTICLE VI - Election and Officers

Sec. 1 Any member that has been in good standing for a minimum of 1 year may be nominated at the November meeting. Election will be held at the December meeting.

Sec. 2 Any nominee with unpaid dues will automatically be withdrawn prior to the vote count.

Sec.3 All ballots will be opened and counted at the meeting by an unbiased party appointed by the Present Board of Directors members. If a nominee is running for an office that is uncontested that person will automatically assume said office.

Sec. 4 The newly elected officers will assume their duties at the January meeting.

Sec. 5 When an officer leaves their position before their term is up, the position will be appointed by the Board for tile completion of the term, and then filled by the regularly scheduled election.

Sec. 6 There will be no absentee ballots, unless you are a member in good standing and are unable to make the meeting due to illness or catastrophe.

ARTICLE VII - Dues

Sec. 1 Annual membership dues for all members will be the following: \$20.00 for individuals or family, \$10.00 for members under the age of 18 or over the age of 65. This entitles you to 1 vote, 1 newsletter, and one free classified in the monthly newsletter. All family members are invited to the monthly meetings, but are not entitled to vote. Additional" voting" memberships can be added to the family membership at \$5.00 per person per vote.

Sec. 2 All dues are due by January 15th of each year.

Sec. 3 Any member in arrears after June 15th will have their newsletter subscription terminated and will not be entitled to vote on any club matters until said dues are paid.

Sec. 4 Visitors are welcome at any meeting. After two (2) such visits, they must be advised that further attendance will require their applying for membership. This does not apply, however, to any member's immediate family.

Article VIII - Bills

Sec. 1 All non-operating expenses or bills must be presented to the President who shall authorize payment through the Treasurer.

Sec. 2 No officer or member shall incur any bills without having received prior authorization for the expenditures from the President and Treasurer. Total expenditures shall not exceed \$100.00 in a month period without authorization from the Board of Directors excluding operating expenses, including but not limited to: newsletter printing, postage; hall costs and photography. Exception is made for speaker costs though not to exceed \$250 without approval vote of general membership.

Sec. 3 No officers or members shall receive salary, wages, or inurement for their contributions to the Club.

Sec. 4 Starting June of 2008 an outside auditor will perform a yearly audit on our Treasury account.

ARTICLE IX - Grievances

Sec. 1 Any member wishing to lodge a grievance against another member shall do so to the Board of Directors, in care of the Secretary, and in writing or alternately, may make a motion to be heard at a general meeting. The Board of Directors shall immediately notify that member in writing through the Secretary and request written rebuttal to the charges within (30) days of notification. If the grievance was filed verbally in a general meeting, then the rebuttal shall be read at the next general meeting and floor be opened for discussion. Upon the presentation of both the grievance and the rebuttal, the Board of Directors shall investigate, discuss at the general meeting, and render a decision within (30) days.

ARTIVLE X - Authority

Sec. 1 Robert's Rules of Order Revised shall be parliamentary authority on all questions not covered by bylaws.

ARTICLE XI - Disbandment of Club

Sec. 1 In the event of total disbandment of the Club, all outstanding bills will be paid by the Treasurer and monies held in the Treasury over \$500 will be donated to a tax exempt avian organization that qualifies under section 501 C of the IRS code. The final Board of Directors shall decide on it. The remaining balance will be held in a trust fund for no more than 3 years for possible use in' the restart of the Club in the event a new Club is formed, said \$500 will be dispersed to the newly formed Club.

Sec.2 After 3 years any money that is still held in trust will be donated to the previously defined avian organization.

ARTICLE XII - Amendments

Sec. 1 The Board of Directors or a member in good standing may propose Amendments to the bylaws at any regular meeting. Any revisions shall be printed and made available for members to review in the monthly newsletter. The revised bylaws shall then be voted on a quarterly basis, at the March, June, September and December meetings.

As many of you know, I am an active volunteer and foster home for the Bailey Foundation. I am currently fostering the 6 Bailey birds described below, and will be happy to give you details on any one of them. There are many other birds available, please check out their website <http://www.bailey-foundation.org/>

Buddy – 14 YO male Lesser Sulphur Crested Cockatoo

Buddy seems to be a good natured bird who craves human contact. He has been mistreated, however, and bites out of fear. In recent weeks, he has come to trust people and allows petting of his beak, chest, head and legs through the cage bars. His behavior remains unpredictable, however, and he would do best in a home with a seasoned bird owner, where he will receive consistent love and attention.

Mango – 2 YO male Peach Front Conure

Mango is a young, friendly bird who loves fruit, especially dried papaya, and enjoys slowly destroying his wooden toys. He tends to bite your fingers when he steps up, but this is decreasing over time, and I believe he will be a good companion with consistent positive reinforcement from his caregiver. Mango can be a bit noisy, as with most conures, but does not scream excessively.

Roscoe – 10 YO male Nanday Conure

Roscoe is as charming as he is naked!! He has plucked his chest and back repeatedly, and feathers will most likely not regrow in these areas. His remaining feathers are beautiful, however, and his tail is long, full, and gorgeous!! He is very friendly, loves a good head scratch, and has a sweet, low voice that sounds like a whisper. He plays vigorously with his toys, and screams for joy while doing it!!

Congo – 8 YO male? Patagonian Conure

Congo is an exceptionally beautiful Patagonian, and is in perfect feather. He has a comical voice, and says a few words; he also plays rough with his toys, but is friendly once outside his cage. Congo enjoys human interaction, and will run through his repertoire of sounds and words to get it!

Lucky – male Nanday Conure with special needs

Lucky is a very gentle and sweet bird who has only one leg. How and when he lost his leg is unknown; however, he seems to have adapted well to his disability and gets around fine! His cage has been customized for his needs, to minimize injury from falling, but Lucky hardly seems to think he needs it! He can be quite vocal when he greets his family, and thoroughly enjoys company.

Bing – Cherry-Head Conure

Bing was removed from a bad situation and brought to the Bailey Foundation for help. He was plucked in spots, but his feathers have regrown nicely and he is learning to trust people again. He says a very words, and appears to want to be with people. He will mutter under his breath if people are nearby, but not paying attention to him. He will be a fine companion with patience and understanding.
