
PRESIDENT'S MESSAGE

Bylaws to be voted on at the June Meeting (The ones in red are the changes that will be voted on)

Article 4 Section 1: The officers of the club shall be a President, 1st Vice President, 2nd Vice President, a Secretary and a Treasurer all voted on by the membership for a one (1) year term.

The officers of the club shall be a President, 1st Vice President, 2nd Vice President, a Secretary and a Treasurer all voted on by the membership for a two (2) year term. The voting will take place every odd year.

Article 4 Section 2: The club shall have a Board of Directors consisting of the President, 1st Vice President, 2nd Vice President, Secretary, Treasurer, and 3 Membership Representatives for each 100 members then 1 additional Membership Representative will be elected/appointed by the Board of Directors for each additional 25 members.

The club shall have a Board of Directors consisting of the President, 1st Vice President, 2nd Vice President, Secretary, Treasurer, and up to but no more than five (5) Membership Representatives will be appointed by the Board of Directors on an "as needed" basis. The appointment of the Membership Representatives shall take place after the election of the Board of Directors.

Article 4 Section 5: No one shall be eligible to run for a Board position if they so hold another Board position with another club, but can be so appointed by the Board of Directors if needed.

Article 5 Section 6: The Treasurer shall receive and have charge of all monies belonging to the club and shall disperse it at the direction of the Board of Directors. He/She is also responsible for collection of all membership fees and forwarding membership forms to the Member Representatives who will keep an accurate record of membership status. On the expiration of his/her term of office, he/she will turn all monies and accounts (including records) over to the incoming Treasurer.

The Treasurer shall receive and have charge of all monies belonging to the club and shall disperse it at the direction of the Board of Directors at the Board meetings. A Treasurers report shall be read and approved at every Board meeting, then be shared with the general membership at the monthly meetings. He/She is also responsible for collection of all membership fees and forwarding membership forms to the membership representatives who will keep an accurate record of membership status. On the expiration of his/her term of office, he/she will turn all monies and accounts (including records) over to the incoming Treasurer.

Article 5 Section 8: The Board of Directors shall exercise, conduct, and account for the property and affairs of the club. In order to be an officer on the Board, said officer must be a member in good standing. A member shall be considered a member in good standing if their yearly dues are paid up-to-date and they have attended 50% of the meetings in the previous year. A member of the Board of Directors missing 3 or more consecutive Board meetings will automatically be dismissed from the position and said position will be open to appointment by the Board for the completion of term.

The Board of Directors shall exercise, conduct, and account for the property and affairs of the club. In order to be an officer on the Board, said officer must be a good member in good standing. A member shall be considered a member in good standing if their yearly dues are paid up-to-date and they have attended 50% of the meetings in the previous year. A member of the Board of Directors missing three (3) or more consecutive Board meetings will be reviewed for dismissal from the position and said position will be open to appointment by the Board for the completion of term if needed.

Article 6 Section 1: Any member that has been in good standing for a minimum of 1 year may be nominated at the January meeting. Election will be held at the February meeting.

Any member that has been in good standing for a minimum of one (1) year may be nominated at the November meeting. Election will be held at the December meeting.

Article 6 Section 4: The newly elected officers will assume their duties at the March meeting.

The newly elected officers will assume their duties at the January meeting.

Article 7 Section 1: Annual membership dues for all members will be the following: \$20.00 for individuals or family, \$10.00 for members under the age of 18 and over the age of 65. This entitles you to 1 vote, 1 newsletter, and one free classified in the monthly newsletter. All family members are invited to the monthly meetings, but are not entitled to vote. Additional "voting" memberships can be added to the family membership at \$5.00 per person per vote.

Annual Membership dues for all members will be following: \$20.00 for individuals or family, \$10.00 for members under the age of 18 and over the age of 62. This entitles you to one (1) vote, one (1) newsletter, and one (1) free classified in the monthly newsletter. All family members are invited to the monthly meetings, but are not entitled to vote. Additional "voting" memberships can be added to the family membership at \$5.00 per person per vote.

Article 7 Section 2: Dues will be prorated for members joining after January. All dues are due by January 15th of each year.

Article 7 Section 3: Any member in arrears after March 15th will have their newsletter subscription terminated and will not be entitled to vote on any club matters until said dues are paid.

Article 8 Section 4: Starting June of 2008 an outside auditor will perform a yearly audit on out Treasury account.






